**Decarsky Park Update:** The DRC agreed to contribute funds to the construction of the 4<sup>th</sup> ballfield field so it will open with the rest of the park. Three were originally planned to open in the first phase. The Decarsky project will go to City Council on April 23<sup>rd</sup>. The dog park received a donation of \$19,000 per year over the next 3 years, so it all will be completed in the first phase. The park is estimated to be open in 2021. There is project through Sedgwick county extend the sidewalk to the park.

**Playground Resurfacing Project:** The turf resurfacing is complete with additional drainage to take water off the splash pad.

**RRR Resurfacing:** The sandblasting, painting and punch list items have been completed. The pools will be filled May 5<sup>th</sup>. There will be an energy for the start-up sequence to see if energy consumption can be reduced. The concession area has been updated.

**Tree Planting Guide 2019:** Dr. Griffin creates the tree guide for us. Upon edits adding “deciduous holly”, motion by Jason Griffin to approved the guide. Seth Berg second. All yea, motion carried.
