

ORDINANCE NO. 2331

AN ORDINANCE INCLUDING, INCORPORATING, AND ANNEXING CERTAIN LAND INTO THE LIMITS AND BOUNDARIES OF THE CITY OF DERBY, KANSAS.

WHEREAS, the governing body of the City of Derby, Kansas (“City”) announced its intention to consider annexation of land that is platted, and some part the land adjoins the City by adoption of its Resolution No. 33-2017 on August 8, 2017; and

WHEREAS, said resolution fixed October 10, 2017 at 6:30 p.m. as the date and time for a public hearing on such proposed annexation before the governing body of the City and notice thereof was mailed to interested parties and published as required by law; and

WHEREAS, such public hearing was conducted on October 10, 2017 and all parties present at such meeting and interested in the proposed annexation were heard by the governing body of the City;

NOW THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF DERBY, KANSAS:

SECTION 1. That the following-described land is hereby included, incorporated, annexed, and brought within the corporate limits of the City of Derby, Sedgwick County, Kansas, pursuant to K.S.A. 12-520, as amended, and other relevant authority:

“Piper Lane Addition,” Sedgwick County, Kansas, including all Lots, Blocks and Reservations platted therein, said plat being located within the Southeast Quarter (SE/4) of the Southwest Quarter (SW/4) of Section Eight (8), Township Twenty-nine (29) South, Range Two (2) East of the Sixth Principal Meridian, Sedgwick County, Kansas, said plat containing the following property, to-wit:

All of Lots 1 through 2, inclusive, Block A, TOGETHER with all other public rights-of-way, all in Piper Lane Addition, Sedgwick County, Kansas;

Together with;

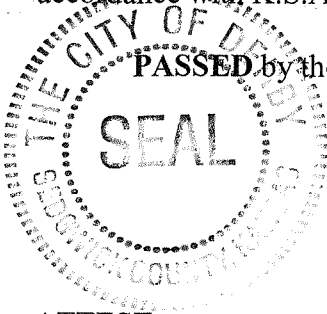
Road right-of-way for 87th Street South from the east line of the plat of 87th & Rock Commercial, Derby, Sedgwick County, Kansas to the east line of the plat of Piper Lane Addition, Sedgwick County, Kansas.


SECTION 2. Should any section, clause, sentence, or phrase of this ordinance be found to be unconstitutional or is otherwise held invalid by any court of competent jurisdiction, such invalidity shall not affect the validity of any remaining provisions herein.

SECTION 3. This Ordinance, following its passage and publication once in the City’s official newspaper, shall take effect on November 8, 2017 pursuant to K.S.A. 12-523.

SECTION 4. The City Clerk shall certify a copy of this ordinance to the county clerk, the register of deeds and the county election commissioner of Sedgwick County, Kansas for filing, all in accordance with K.S.A. 12-522, and amendments thereto.


